Thank you for your interest in the YMCA financial assistance. We offer financial assistance to individuals and families who are not able to pay full fees for Y memberships and/or programs that we offer here at your local YMCA.

To apply for financial assistance, please bring all the following information to the YMCA Welcome Center:

1. Complete the financial assistance application.
2. A copy of your **MOST RECENT** federal income tax return. If you do not file federal income taxes, please call 1-800-829-1040 for a verification of non-filing letter or you can go to the IRS.gov for other information.
3. Your two most recent paycheck stubs or letter from your employer verifying your employment if employed at the time you apply for assistance. If you are unemployed, draw social security or a full-time student, please provide a summary of your unemployment benefits, SSI paperwork, or financial aid benefits and student schedule.

Please mark out all social security numbers, tax ID numbers banking information and/ or credit card numbers before submitting any paperwork.

Applications **MUST** be submitted with all required documentation. **Incomplete applications WILL NOT BE processed.** All financial assistance is distributed on a case-by-case, first-come, first-served basis.

Please do not sign up for any membership or register for any programs before you submit your financial assistance.

You will be contacted with two weeks regarding your qualifications and next steps.
